ORDER

- Whereas, the AICTE is a statutory body established by AICTE Act, 1987. The said Act "provides for establishment of an All India Council for Technical Education with a view to the proper planning and coordinated development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
- Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps as it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards. Further, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned.
- Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Institutions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
- Whereas, **INDUR INSTITUTE OF ENGINEERING & TECHNOLOGY, PONNALA (V) SIDDIPET (M) MEDAK DISTRICT 502 277, MEDAK (PID: 1-5750084) RUN BY INDUR EDUCATIONAL SOCIETY, FLAT NO. 101, KK TOWERS, NAGARJUNANAGAR, TARNAKA** subsequent extension of approvals time to time.
- Whereas, the complaint was received by AICTE that 240 institutes, including **INDUR INSTITUTE OF ENGINEERING & TECHNOLOGY** land in Telangana State does not possess the document issued by Competent Authority for land such as conversion certificate, approval of building plan and other related document.
- Whereas, based on above complaints Scrutiny of all institutes including **INDUR INSTITUTE OF ENGINEERING & TECHNOLOGY** was conducted during 23-28 March 2018. The Scrutiny Committee has noted several deficiencies. The report of Scrutiny Committee is categorized the institute in 3 list i.e. (i) Covered under G.O. MS 111 dated 8.3.2018 (ii) Located over either Bhoodan land or under land ceiling surplus land (iii) all remaining 205 institute. **INDUR INSTITUTE OF ENGINEERING & TECHNOLOGY** falls in 3rd list. The deficiencies were placed before Special Committee on 10/04/2018 for examination. The recommendation of Committee is as under: -

S.No.	Deficiencies	Recommendation of Special Committee
1.	Land Conversion Certificate & Land Use Certificate	EOA TO BE GRANTED
2.	Complete Building Plan/Site Plan not acceptable [Approved by Grampanchayat only]	
3.	Structural Stability certificate not presented/acceptable	
4.	Occupancy Certificate not acceptable.	

With respect to 3rd list of 205 institutions, wherever, "EOA be granted" has been recommended, it is with the condition that they must comply with the deficiencies noted against each of them and the same be verified before those institutions submit their respective applications for EOA for A/Y 2019-2020.

7. Whereas, the Executive Committee (EC) in its 116th Meeting held on 26/04/2018 considered the report of Special Committee and decided as under: -

"The Executive Committee deliberated on the recommendations of Special Committee in the matter of Scrutiny of land related documents of 238 institutions in South Central Region. The Special Committee submitted its report for all 238 institutions after verification of land and building related documents and categorized them in three categories i.e. A, B & C.

The EC approved the recommendations of the Committee for grant of 'No EOA'/'No Admission' for all the 22 institutions under 'category A' which fall in GO. 111.

The EC also approved the recommendations for grant of EOA for the A/Y 2018-19 for the 205 institutions listed under 'category B' with a condition that these institutions should comply with the deficiencies as informed before applying for EOA for AY 2019-20.

The EC noted that verification from the Competent Authority of the State Government about the veracity of the document in respect of 11 institutions listed under category 'C' is yet to be received. The EC considered the matter and decided that in case the State Government informs AICTE about genuineness or otherwise regarding documents submitted by these institutions before April 30, 2018, AICTE will accordingly act while taking the decision on the approval of those institutions; otherwise Extension of Approval (EOA) will be granted for 2018-19 with a condition that these institutions should comply with the deficiencies as informed before applying for EOA for AY 2019-20. The EC also authorized Chairman, AICTE to take a decision based on the information received from the State Government and the same may be placed before the EC for ratification.

8. Therefore, after examining the entire matter in the facts and circumstances mentioned herein above, and in terms of the provisions of the Approval Process Hand Book for A/Y 2018-19, it has been decided to grant EOA to **Indur Institute Of Engineering & Technology, Ponnala (V) Siddipet (M) Medak District 502 277, Medak** for A Y 2018-19 subject to condition that compliance of above deficiencies shall be furnished to Regional Officer, Hyderabad before applying for EOA in A/Y 2019-20.
9. In view of the above, it is directed that institute shall submit the compliance of all deficiencies as mentioned above to R.O., office, Hyderabad before applying for EOA in A/Y 2019-2020.
